## Canadian Residents

### Allowances: Entering the U.S.

Canadians can shop Duty Free before entering the U.S.	Alcohol	Tobacco
	Alcohol: 1L or Beer: 1 Case or Wine: 1.5L	1 Carton Cigarettes + 50 Cigars
Any trip: you may bring gifts up to \$100 USD and 100 Cigars		
 You can exceed these allowances See reverse for details		

### Allowances: Returning to Canada

Duration	\$	Alcohol	Tobacco
Less than 24 Hours	No Limit	None	None
24 to 48 Hours	\$200 CAD	None	None
After 48 Hours	\$800 CAD	Alcohol: 1.14L or Beer: 1 Case or Wine: 1.5L	1 Carton Cigarettes + 50 Cigars + 200 Sticks + 200g of Tobacco

## Frequently Asked Questions

### Why should I buy Duty Free?

The Duty Free offers a large selection of world class brands at reduced prices and no tax including products not readily available at Canadian & U.S. stores such as British and Swiss chocolate, Canadian spirits, wine & beer. It's also a convenient place to shop along the way.

### Can I purchase more than my allowance?

Yes you can. You may be required to pay duty and taxes on the excess purchases. See  reverse for details.

### Can I buy Duty Free if I'm on a day trip?

Yes you can. However, you technically do not have a duty free allowance so you may be asked to pay tax and duty on purchases. See  reverse for details.

## U.S. Residents



### Allowances: Returning to the U.S.

Duration	\$	Alcohol	Tobacco
Any Trip	\$200 USD	5oz or 150ml	10 Cigars
After 48 Hours	\$800 USD	Alcohol: 33.8oz or 1 Litre	1 Carton Cigarettes + 100 Cigars

### You can exceed the allowances

#### **Entering U.S.** (CDN & U.S. Residents)

You may be asked to pay these approximate duty rates on excess purchases (over and above your allowance):

<b>Liquor</b>	\$2.00 - \$3.00 USD per bottle*
<b>Beer</b>	\$1.90 USD per case*
<b>Tobacco</b>	\$10.07 USD per carton*

#### **Entering Canada** (CDN & U.S. Residents)

You are allowed to return to Canada with excess amounts. However, duty on excess alcohol and tobacco is excessive and not recommended.

## Frequently Asked Questions

### **Why should I buy Duty Free?**

The Duty Free has a large selection of world class brands at reduced prices and with no tax including products not readily available at U.S. stores such as British and Swiss chocolate, Canadian spirits, wine & beer. When the U.S. dollar is worth more the savings are even better.

### **Can I exceed my personal allowances?**

Yes you can. The tax and duty rates are minimal for additional purchases, so your savings are still significant if you are asked to pay. See  above for more details.

### **Can I buy Duty Free if I've only been away for the day?**

Yes. Your daily allowance is \$200 which can be used to buy fragrance, skincare, fashion and food. You can also purchase alcohol & tobacco which may be subject to a small amount of duty. See  above for more details.
